Notification

Whereas, the Ministry of Road Transport & Highways, Government of India as per provision under section 134 A of the MV Amendment Act 2019 has notified rules for Good Samaritan vide notification no. GSR-594E dated 29-09-2020 for providing legal protection to the people who give reasonable assistance to those who are, or who they believe to be, injured, ill, in peril, or otherwise, incapacitated as annexed herewith as **Annexure-A**.

And whereas, the Ministry of Road Transport & Highways, vide notification no. RT-25035/27/2021-RS dated 4th October 2021 has notified "**Guidelines for the Scheme for grant of Award to the Good Samaritan who has saved life of a victim of a fatal accident involving a motor vehicle by administering immediate assistance and rushing to Hospital/Trauma Care Centre within the Golden Hour of the accident to provide medical treatment**", as annexed herewith as **Annexure-B**.

 Now, therefore, in pursuant to Para 7.3 of above guidelines, the Governor Himachal Pradesh is pleased to constitute a State Level Monitoring Committee and District Level Appraisal Committee to monitor the proper implementation of the Scheme as well as for selection of Good Samaritan for grant of award in accordance with the guidelines for the Scheme.

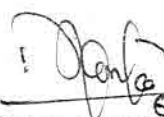
